#### INTRODUCTION

This study, which we prepared as part of the lectures of Fundamental Moral Theology at the Faculty of Theology of the Catholic University of Ružomberok in Košice, Slovakia, and significantly updated during the lectures of Fundamental Moral Theology for the Mater Ecclesiae Institute at the Pontifical University of St. Thomas Aquinas Angelicum in Rome, we focused on finding a definition of moral theology with the help of several personalities, especially of European moral theology (many of them we had the opportunity to know and listen in person).

Given the challenges of some important moralists (e.g., Prof. Peschke, Weber, Schockenhoff, etc.), we also focused on removing the dichotomy between theological and philosophical ethics in finding a place for moral theology at the heart of modern civil society. In the third chapter we tried to point out the importance of individual tasks and sectors of moral theology within other scientific disciplines as well as the position of the moral theologian in the complex of Catholic theological research and the role of the Magisterium of the Church. At the same time, we also addressed some modern directions of moral theology (e.g., autonomous ethics) and their critical assessment by the Magisterium of the Church, or even the Pope John Pau II himself.

In the fourth penultimate chapter, we tried to bring readers closer to the short history of the scientific subject of Moral Theology, which clearly shows the historical development not only of this scientific department, but also of the whole Church. Finally, in the last fifth chapter of this first part of our study, we focused on a comprehensive interpretation of the holistic action of man with the help of biblical and systematic dogmatic theology.

After completing this study, we would like to focus on its continuation in the second part, where we would like to point out the scientific elaboration of individual elements of Fundamental Moral Theology, which we have not yet published. In 2021, we published the study *Moral and Theological Virtues: From Moral Theology to Social Ethics* at Angelicum University Press. We therefore have to administer the fundamental elements of Moral Theology, such as Moral Law, Moral Conscience, and Sin.
